CALL IT TREASON

12th August, 1986.

DEAR MEMBERS, especially ACTIVISTS: My apologies for the lateness of this June issue of 'STOP PRESS'. Meeting other urgent dead-lines first forced its postponement, then submissions to the Government on education and other topics took priority, along with research into 'Witchcraft in the Classroom', for my speech on 9th August in Sydney at F.O.L.'s. 1986 National Education Conference.

With that accomplished, here is our 'STOP PRESS' and one of Alan Gourley's valuable booklets, "Call It Treason", which complements our two earlier Magazines, and I pray it will stir many to action against the sinister Australia Acts, which now permit an anti-Christian socialist AUSTRALIAN REPUBLIC.

Christians, we cannot afford to let these Acts go unchallenged! We need to remind our MPs that Parliaments pray each sitting day that their laws will GLORIFY GOD and be for the good of HIS CHURCH, HIS PEOPLE, in this HIS COUNTRY. Those who reject political involvement, saying we are not a Christian country, miss a great opportunity for serving our Lord in the law-making process.

As the late A.A.Chresky (former Federal Member for Griffith) said, two things are established in law (1) that MPs are to present the recommendations of the electorate, in the form of proposed legislation, to the Crown for acceptance or rejection; and (2) that the Crown is duty-bound at all times to protect the people (e.g. from unwanted laws.) It appears then that change legally requires the consent of, or perhaps even initial major support from, the electorate.

The Australia Acts were enacted through a reverse process -

- (a) we, the people, were deliberately kept ignorant of momentous changes contrived over many years to render the Constitution and the Crown powerless;
- (b) no referendum, poll or canvassing of any sort was conducted to enable us, the people, to advise our MPs whether or not we wanted to lose the established protection of the Monarchy under God, and head towards a republic;
- (c) we, the people, were forced, by our MPs' passing these unwanted laws, to reject God's anointed Monarch and her God-given power to protect us.

This process ignored the Queensland Constitution's requirement for a referendum. Our Queensland Constitution, like any law passed by our Representatives, is our property, and its power (to require a referendum) is PEOPLE POWER to protect us against any government's unbridled power. After being given all the facts, the people, under God, have the responsibility of deciding policy. The MPs are to do the bidding of the electorate, not vice versa.

Your local Representative has no constitutional duty to bow to the dictates of any political Party, and no right to place his Party before the people he represents. So when all Parties in all Parliaments agree to hoodwink the people and take away those very measures that hinder Godless men from seizing absolute power over us, such action points to a PLOT, by those whose goal is CONTROL.

When plotting and conspiring involves implementing, not the wishes of the electorate, nor even laws to the glory of God, but the godless policies of some overseas or external groups of people, with evil intent against Christ, His church, and His appointed system of rule by Monarch and Governors under God, then what other word is there to describe such activity but the word 'TREASON'?

Dear Patriotic Australian,

You may not know of me although I have become known to a lot of good Aussies over the last year through sale of 3,000 "How to Avoid the Looming Catastrophe" books plus various papers and the new "Assault on Childhood" book.

Treason is a nasty word but nevertheless accurate. The case is somewhat complicated because of the secretive 'gradualism' policy of those who seek power. This policy leads people to accept and feel comfortable with dangerous developments.

Possibly no single act of political intrigue constitutes treason. We only realize that treason is involved when we understand the original concept of our Australian Constitution and relate that to the changes taking place in political behaviour and the agreements behind these changes.

For instance the 'Australia Act' may seem to be, as its advocates claim, innocuous. But the fact that it was brought to conclusion without publicity is alone enough to make it conspiratorial and immoral in relation to the letter and spirit of the Constitution. Although it may seem to increase the powers of the State Premiers, it equally appears to increase the power of the Commonwealth and in particular the power of 'political parties' over the people of the States. People no longer have full protection of the Crown, and public restraints, such as imposed through the 'Bill of Rights' and 'Human Rights Commission', grow in force. The rule, 'divide and conquer' becomes more effective.

→ That, though it be passed off as irrelevant, is no small matter, but perhaps even more important is that a precedent is created. If political parties can get away with such irregularities as this, then they obtain the right (by public acceptance of precedent) to other constitutionally illegal power grabs.

I say this here because it was not made sufficiently clear in the booklet itself. My excuse is that time is so short that I dared not hold up publication until all evidence and argument were assembled. People must be warned so as to enable action that will make clear their concern. If this is done, political parties will not dare impose their assumed powers before we (the general public) have time to take up our responsibilities and demand a return to our original constitution.
